The January meeting of the Decide DeKalb Development Authority was called to order at 8:44am on Saturday, January 13th, 2024, at the Decide DeKalb Office, 1 W Court Square, Suite #460 Decatur, Ga 30030.

#### I. CALL TO ORDER

Chair Bolia presided.

#### II. ITEMS FOR DECISION

#### A. Swearing in Ceremony Alan Ferguson and C. David Moody Jr.:

Chair Bolia administered the oath of office for the two new board members. Once complete Mr. Ferguson and Mr. Moody were photographed and congratulated by fellow board members and staff on becoming the newest members of the Authority's board.

#### B. Approval of November 2023 Board Meeting Minutes:

Mr. Greenberg made a motion to approve the November Board Meeting Minutes. Ms. Coblentz seconded the motion which was unanimously approved.

#### C. Approval of October 2023 Financials:

Ms. McAbee presented the October 2023 financials.

Current assets are as follows: Cash \$1.8m, Total investments \$833k, Accounts Receivable \$436k.

Mr. Moody made a motion to approve the October 2023 financials. Vice Chair Gooch seconded the motion which was unanimously approved.

#### D. Approval of Amended Procurement Policy:

Ms. Mason presented the amended procurement to the board. The amended procurement policy was first brought to the board for discussion in July 2023. The policy establishes a financial process by which expenditures for services or goods are acquired from a qualified and competent vendor through a competitive process and are properly obtained, monitored, and controlled.

The proposed changes from the existing policy include increasing threshold amounts for the written quote and RFP requirements and adding vendor E-verification and other process requirements. Board approval would be required for purchases over \$10k(unbudgeted) or \$50k (budgeted).

The updated policy has been reviewed by the legal team at AGG and has been brought to the Board for final approval.

Mr. Greenberg made a motion to approve the procurement policy. Ms. Coblentz seconded the motion which was unanimously approved.
